### POLICY DOCUMENT FOR SPECIALLY ABLED PERSONS

The government of India formulated the national policy for persons with disabilities in February 2006 which deals with educational rehabilitation of persons with disabilities. Therefore, in view of this, GGI has implemented these policies in its teaching and learning process. The GGI's policy recognize that person with disabilities are valuable human resources for the institution and seeks to create an environment that provides equal opportunities, protection of their rights and full participation in the academic environment.

#### The focus of the policy is on the following:

1. To ensure that the design of the building such as ramp/lift should be according to the disable persons.
2. To ensure the accessible, gender-sensitive, safe, usable and functional washroom facilities should be provided for disabled persons.
3. To ensure the proper text and pictogram signage such as lights, display, boards, signpost, are necessarily located at the appropriate place in the campus.
4. The use signage in accordance with local customs and standards should be used that indicates more evident to everyone and particularly helpful for specially-abled persons.
5. Learners with disability need to be adequately and appropriately supported in and out of the classroom with the right resources and assistive technology, and with leadership, teaching staff and campus communities that are responsive to their needs.
6. Provision of class room at ground floor for disable candidate should also be ensured.
7. Provision for enquiry and information such as human assistance should be given to the need one.
8. Special facility of wheel chairs is to be provided for injured or specially-abled students.

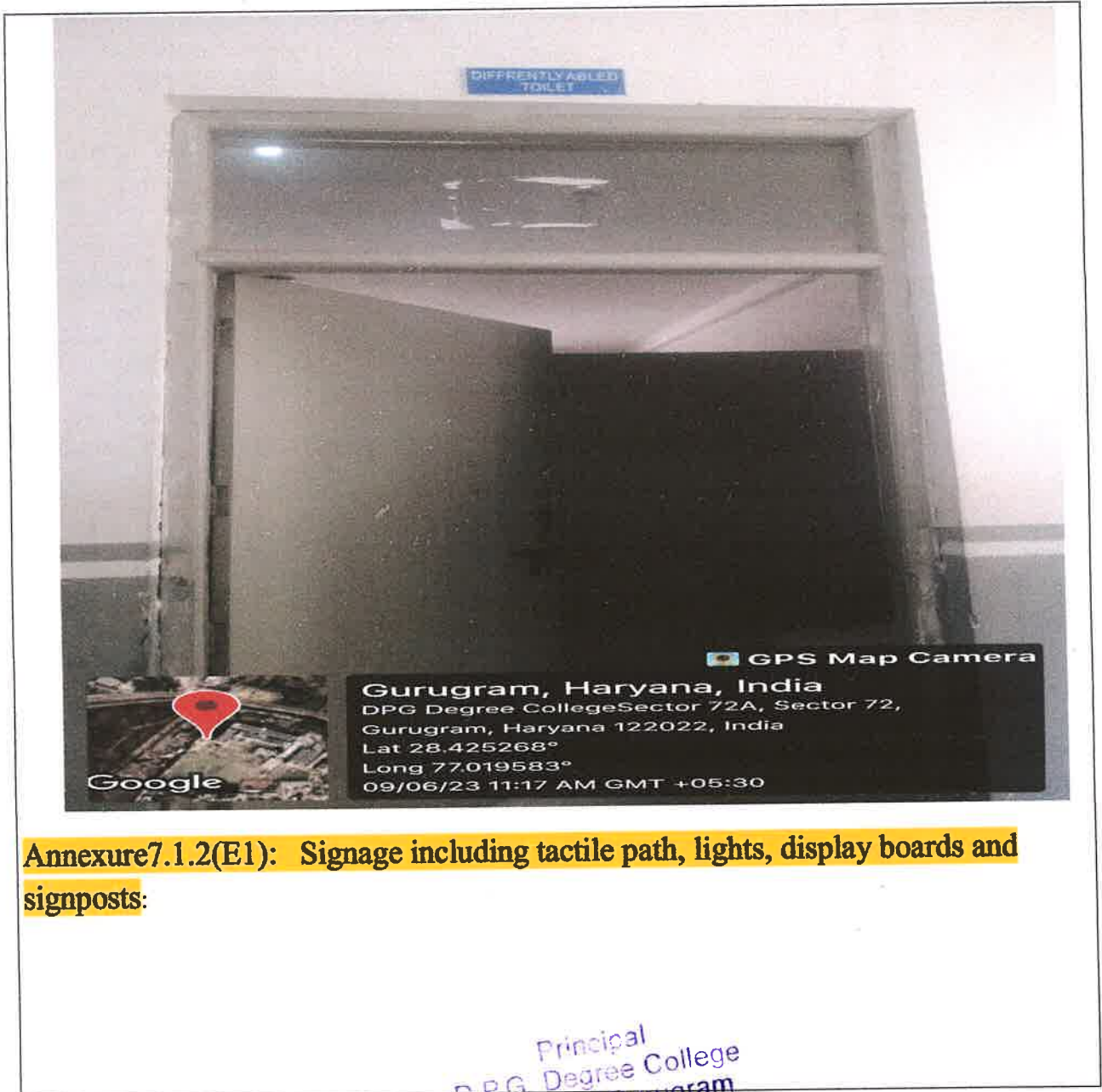

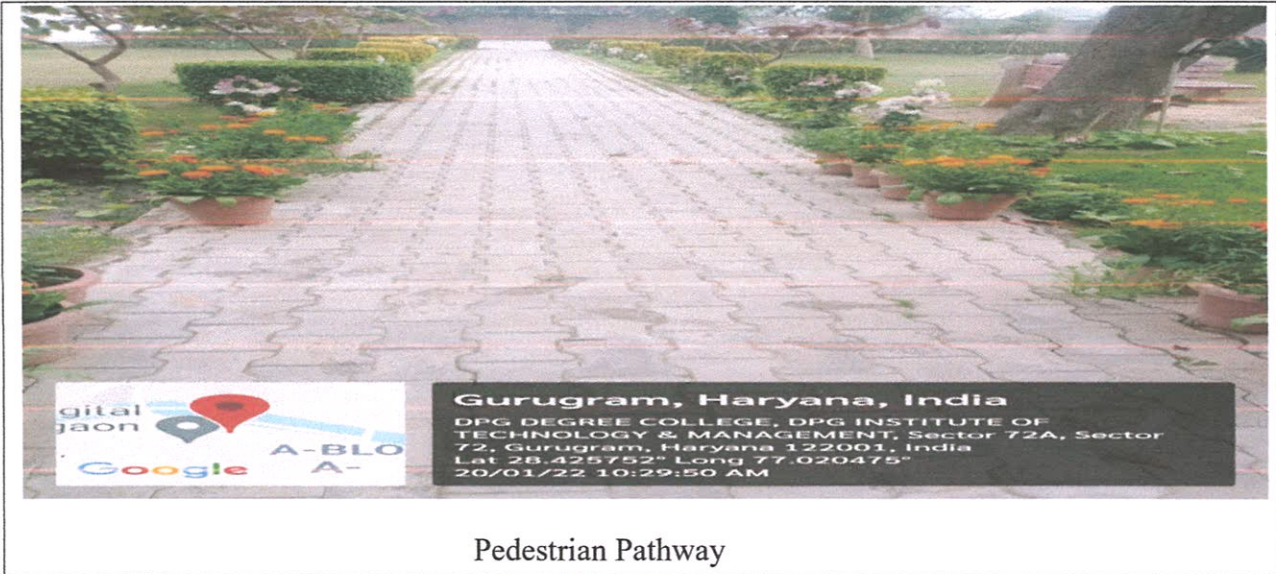
