MEMORANDUM OF UNDERSTANDING

BETWEEN

THE INSTITUTE OF COST ACCOUNTANTS OF INDIA (ICMAI) - GURGAON CHAPTER, M-46,
1ST FLOOR, OLD DLF COLONY, SECTOR 14, GURGAON, HARYANA 122001

AND

DPG DEGREE COLLEGE SECTOR -34, GURGAON, HARYANA 122001.

This Memorandum of Understanding (MOU) is made and entered into on this 18th day of June 2025, by and between:

1. The Institute of Cost Accountants of India (ICMAI) - Gurgaon Chapter, situated at M-46, Sector -14, Gurgaon, Haryana 122001 (hereinafter referred to as the "First Party"); and

2. DPG Degree College Sector -34, Gurgaon 122001 (hereinafter referred to as the "Second Party").

The First Party and the Second Party may collectively be referred to as the "Parties".

1. Purpose and Scope

The purpose and scope of this Memorandum of Understanding is to establish a framework for collaboration between the Parties for promotion of CMA course in oral class mode conducted by "The Institute of Cost Accountants of India" among the students of DPG Degree College and arrangement of necessary classes for imparting preparation facility to students desiring of opting CMA course through DPG Degree College only. This MOU is for academic purpose only.

2. Objectives

1. Educational Excellence: Provide students with a robust foundation in finance, costing, accounting, banking, taxation, and insurance, through a combination of theoretical knowledge and practical application.
2. Innovative Teaching: Employ cutting-edge teaching methodologies including interactive classroom discussions, comprehensive case studies, and practical training to enhance learning outcomes.

3. Responsibilities

3.1 Responsibilities of College

1. Provision of Facilities:- Provide fully furnished smart classroom for the CMA course students opting CMA course classes conducted by DPG Degree college only.
2. Promotional Space: Provide space for promotional materials and prospectus sales.
3. Volunteer Administrator: Assign a volunteer administrator to manage daily operations.
4. Payment to Faculty shall be made directly by the College on per class basis and shall be disbursed on monthly basis.
5. Conduct classes and manage class as per schedules.
6. To Enroll desiring students in oral class mode with Gurgaon Chapter of ICAI.

3.2 Responsibilities of ICAI - Gurgaon Chapter

1. Educational Materials: Provide necessary study materials.
2. Faculty Provision: Arrangement of qualified/competent faculty at reasonable honorarium
3. Class Management: Coordinate with College to design class schedule



4. To train staff of DPG College for assistance in student's registration process in CMA Course.

5. The first party will actively engage to help the delivery of coaching and training of students of Second party.

4. Duration

This MOU shall be effective for a period of five (5) years from the date of execution, unless extended or terminated earlier by mutual agreement.

5. Dispute Resolution

In the event of any disputes, the Parties agree to resolve them through negotiation, failing which the matter shall be referred to mediation or arbitration.

There is no compulsion on any party or the student to take CMA Course classes through DPG College.

6. Amendments

Any amendments to this MOU must be made in writing and signed by both Parties.

7. Termination

Either party may terminate this MOU with a 30-day written notice. Termination shall not affect any prior obligations.

The MoU will not be effective if sufficient number of students do not opt for CMA course classes through DPG College.

This MOU is executed by the duly authorized representatives of the Parties on the date first written above.
